| Day & Date | As per TO Rule | Description |
|------------------------------|----------------------------|---|
| Thursday 15.07.2021 | Rule 14(1)(b) & Rule 16 | Meeting of the Executive Committee to approve the Election Schedule and appointment of 3-Member Election Commission for the year 2021-2022 |
| Friday 16.07.2021 | Rule 18(3)(a)(b) | The Election Schedule shall be displayed on the notice board, website and also submit to the Regulator within seven days of the approval of the election schedule by the Executive Committee. |
| By Tuesday 20.07.2021 | Rule 18(2) | The changes if any regarding name of representative shall be sent to the Secretary General along with necessary proof of eligibility within three days of the announcement of election schedule. |
| Thursday 22.07.2021 | Rule 18(4) | The Secretary General shall display within seven days of the announcement of election schedule the provisional list of all members eligible to vote along with their NTN, STN if applicable. The name and CNIC number of their representative at the notice Board/website. |
| By Monday 26.07.2021 | Rule 18(4) | The members who have any objection to the entries/changes in the list of voters shall send their objections in writing to the Secretary General within seven days of the Issuance of the Provisional List. |
| By Saturday 31.07.2021 | Rule 18(5) | The Secretary General shall within five days from receipt of objection under sub Rule (4) rule 18 of Trade Organization Rules 2013, intimate action on the objection or changes if any. |
| Tuesday 03.08.2021 | Rule 18(6) | Any person aggrieved by the decision of the Secretary General may within three days of receipt of the decision, make a representation to the Election commission which shall decide the case within three days. |
| Friday 06.08.2021 | Rule 18(7) | Within three days of the decision of Election Commission or in case the Commission fails to decide within the stipulated time any Member of the Provisional List aggrieved by the decision of the Commission may appeal to the Regulator who shall decide the case within 10 days and his decision in this regard shall be final. |
| By Monday 16.08.2021 | Rule 18(7) | The Regular of TOs, will decide the appeals (if any) filed by the Members nominated on the Provisional List |
| Thursday 19.08.2021 | Rule 18(8) | Within two days of the decision of the Regulator or if no appeal has been filed the final voters list shall be displayed at notice board/website and submit to Regulator TOs |





| Monday 23.08.2021 | Rule 18(9) | Within four days of the final voters list, any person who is eligible to contest the election for the vacant post shall send his nomination duly proposed and seconded by a duly registered voter and signed by the candidate to the Secretary General. In the same manner women entrepreneurs desiring to contest the election for the women reserved Seats in the Executive committee will submit nomination papers. |
| Tuesday 24.08.2021 | Rule 18(10) | Within 24 hours of the receipt of nomination papers a copy of the final list of voters shall be provided to each contesting candidate. |
| By Thursday 26.08.2021 | Rule 18(11) | The nomination papers shall be scrutinized by the Election Commission and the list of candidates shall be displayed within 24 hours of the last date of receipt of nomination Papers. |
| Friday 27.08.2021 | Rule 18(12) | The objection if any to the nomination of candidates can be filed to the Election Commission within 24 hours of the issuance of list of candidates including those of Women seats provided that the candidates for a particular seat will file objection for the candidate of the same seat and same class. |
| Monday 30.08.2021 | Rule 18(13) | The Election Commission shall decide on the objections to the nomination of candidates within two days. |
| Thursday 02.09.2021 | Rule 18(13) | Within two days of the decision of election commission or in case the commission fails to decide within the stipulated time any candidate aggrieved by the decision of the Commission or may file an appeal to the Regulator who shall decide within seven days And his decision shall be final. |
| Tuesday 07.09.2021 | Rule 18(13) | The Regular TOs will decide the Appeals (if any) filed by the Candidates |
| Wednesday 08.09.2021 | Rule 18(19) | Notice for the Annual General Meeting shall be sent to all members atleast prior 21 days. The AGM will be held on 30 th September 2021 |
| Thursday 09.09.2021 | Rule 18(14) | Within two days of the Decision of the Regulator, the Election Commission will issue final list of Candidates for the Executive Committee (the Members who wish to withdraw from the seat(s) my submit their consent in writing to the Election Commission |
| Wednesday 15.09.2021 | Rule 18(15) | The polling for election of candidates of the Executive Committee shall be held within five days of display of final list of candidates. The Election Commission / Returning officer shall declare Provisional results on the same day. |
| By Saturday 18.09.2021 | Rule 18(16) | Within two days of the polling any person elected as member of The Executive Committee shall send his nomination for election as an office bearer duly proposed and seconded by an Election Commission. The nomination paper shall be scrutinized by the Election Commission and list of candidates shall be displayed within 24 hours of the last date of receipt of nomination papers. The Members of the Executive Committee will elect one Women nominee on the women reserved seat. |

| Monday 20.09.2021 | Rule 18(17) | The nomination papers shall be scrutinized by the Election Commission and list of Candidates for the Office Bearers shall be displayed within 24-hours of the last date of receipt of nomination papers. |
| Wednesday 22.09.2021 | Rule 18(17) | Display of final list of Candidates for Office Bearers by the Election Commission |
| Friday 24.09.2021 | Rule 18(18) | The polling for election of office bearers shall be held within two days of display of final list of candidates. |
| Thursday 30.09.2021 | Rule 18(19)(20)(21) | The final result of election of members of the Executive Committee and Office bearers shall be officially announced at the Annual General Meeting of the Trade Organization called for this purpose within 15 days of the date of polling under the preceding clause but not later than 30 th of September 2021. The final election results announced in the Annual General Meeting shall be displayed at the notice board/website and submitted to the Director General Trade Organization. |
