**SUBJECT: ISSUANCE OF FINAL VOTER LIST IN COMPLIANCE WITH ELECTION
SCHEDULE FOR THE ELECTIONS OF PESHAWAR CHAMBER OF
SMALL TRADERS & SMALL INDUSTRY FOR THE TERM 2026-2028
AND CONSOLIDATED ORDER NO. 52/2026 DATED 20.08.2026**

It is hereby acknowledged and intimated that, in compliance with the Election Schedule issued for the elections of the Peshawar Chamber of Small Traders & Small Industry for the term 2026-2028, and in particular in complete compliance with Consolidated Order No. 52/2026 dated 20th August 2026, the Peshawar Chamber of Small Traders & Small Industry has issued its Final Voter List for onward conduct of the election process.

The Final Voter List has been issued strictly in compliance with the directions contained in Section V of the aforesaid Consolidated Order, issued by the Director General Trade Organization (DGTO), and in accordance with the Election Schedule, so as to facilitate the continuation and completion of the election process within the prescribed timeline. It is, however, expressly clarified that the issuance of the Final Voter List shall be without prejudice to the remedies of the Peshawar Chamber of Small Traders & Small Industry, particularly in respect of those voters whose names/votes have been excluded pursuant to the impugned order and in this regard Re-hearing application is submitted before the Director General Trade Organization against the relevant findings and exclusion of certain votes.

Accordingly, while the aforesaid rehearing proceedings remain pending and without prejudice to the same, the Chamber has proceeded to issue the Final Voter List strictly and solely in compliance with Consolidated Order No. 52/2026 dated 20.08.2026 and the Election Schedule, so that the remaining electoral process may proceed without unnecessary delay or prejudice to the election timeline
